**RALLY RELEASE AND WAIVER OF LIABILITY**

IN CONSIDERATION OF BEING ALLOWED TO PARTICIPATE IN THE RALLY

1. I/We understand and agree that I will take all necessary precautions and avoid conduct that may cause injury to others.
2. I/WE HEREBY RELEASE AND DISCHARGE THE JAMAICA MILLENNIUM MOTORING CLUB (“JMMC”), the sponsors, officials, medical personnel, volunteers, advertisers, owners and lessees of the rally, the course and each of them, their respective officers, directors, agents and employees, all of which are referred to as “RELEASES”, FROM ALL LIABILITY TO ME, my personal representatives, assigns, heirs and next of kin and covenant not to sue the Releases FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES ON ACCOUNT OF ANY INJURY, INCLUDING BUT NOT LIMITED TO DEATH OR DAMAGE TO PROPERTY, CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE “RELEASES” OR OTHERWISE.
- 2a. I/WE understand that:
  - a. Participation in the rally involves RISK AND DANGER, as does any road vehicular activity of serious BODILY INJURY, including PERMANENT DISABILITY, PARALYSIS and DEATH (‘RISKS’).
  - b. The SOCIAL and ECONOMIC LOSSES and damages which could result from the risk could be SEVERE.
  - c. These risk and dangers may be my own actions, or inactions of others, rules of the rally, the condition and layout of the prescribed course or THE NEGLIGENCE OF THE “RELEASES”.
  - d. there may be OTHER RISKS NOT KNOWN TO ME or that are not readily foreseeable at this time.
3. I/WE ACCEPT SUCH RISKS AND RESPONSIBILITIES FOR THE LOSSES AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS OR DEATH, even if caused, in whole or in part by the NEGLIGENCE OF THE “RELEASES”;
4. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of Jamaica.
